### **DEFINITIONS:**

"Program" means the Licensor software product enclosed with this Agreement.

"Licensor" means the Swedish Institute of Computer Science AB.

"Customer" means the person or organisation in whose name the Program was ordered.

### **LICENCE**

Customer may;

a. use the Program on each machine for which a licence has been purchased (including site licence for up to 49 machines);

b. copy the software herein for archive purposes, to replace defective copy, or for Program error verification by Licensor. Quintus software may not be copied onto any media (e.g., magnetic tape, paper tape, disk memory cartridges, Read Only Memory, etc.) for any other purpose.

c. modify the Program and/or merge it into another program for your use on a single machine. (Any portion of this Program merged into another Program will continue to be subject to the terms and conditions of this Agreement.);and,

d. transfer the Program with a copy of this Agreement to another party only if the other party agrees to accept from Licensor the terms and conditions of this Agreement. If you transfer the Program you must at the same time either transfer all copies, whether in printed or machine readable form, to the same party, or destroy any copies not transferred; this includes all modifications and portions of the Program contained or merged into other Programs. Licensor will grant a licence to such other party under this Agreement and the other party will accept such licence by its initial use of the Program. If you transfer possession of any copy, modification, or merged portion of the Program, in whole or in part, to another party, your licence is automatically terminated.

You must reproduce and include the copyright notice on any copy, modification, or portion merged into another program.

Customer may not;

a. reverse assemble or reverse compile the Program.

b. use, copy, modify, or transfer the Program, or any copy, modification, or merged portion, in whole or in part, except as expressly provided for in this Agreement.

c. retain copies of Program, encryption codes or documentation if asked to return the software at the end of an agreed period of temporary use.

### **TERM**

The licence is effective until terminated. The licence will also terminate upon conditions set forth elsewhere in this agreement or if customer fails to comply with any term or condition of this Agreement. On termination the Licensee shall undertake to destroy the Program with all copies, modifications, or merged portions in any form.

### **LIMITED WARRANTY**

Licensor warrants that the media on which this software product is furnished and the encoding of the Program on the media will be free from defects in materials and workmanship for a period of three (3) months from the date of shipment. If any such medium or encoding proves defective during the warranty period, Licensor will provide a replacement in exchange for the defective medium. Except as to the media on which this software product is furnished, this software product is provided "as is" without warranty of any kind, either expressed or implied. Licensor does not warrant that the functions contained in the Program will meet Customer's requirements or that the operations of the Program will be uninterrupted or error-free.

In order to obtain service under this warranty, Customer must notify Licensor of the defect before the expiration of the warranty period. If Licensor is unable to provide a replacement that is free from defects in materials and workmanship within a reasonable time thereafter, Customer may terminate this licence and return the Program with any associated documentation for credit or refund.
